SGX-listed Karin Tech's subsidiary, Compucon, named Top Contributor in Software Distribution by IBM Hong Kong

Singapore, 28 January 2011 – Singapore Exchange ("SGX") Mainboard-listed Karin Technology Holdings Limited ("Karin" or together with its subsidiaries, the "Group"), a leading electronic and industrial components and IT solutions distributor and outsourcing service provider based in Hong Kong, announced today that its wholly owned subsidiary, Hong Kong-based Computers Limited ("CCL"), was presented the Top Contributor Award – Software Distribution by IBM China/Hong Kong Limited (NYSE: IBM) ("IBM").

The award was presented at the IBM Hong Kong BPO Kickoff Meeting on 18 January 2011 at the Langham Place Hotel in Hong Kong, in recognition of CCL's outstanding sales achievement during the fiscal year 2010.

For the full year ended 30 June 2010, Karin achieved a 4.5% year-on-year increase in net profit to
